Outcomes of the meeting

- The keynote speaker, Martin Shreeve, was both provocative and interesting and the other speakers, Sue Grove and Dr. Ian Donald were informative and well received.
- There was a good response to the Inaugural Assembly Meeting, with more than 40 attendees, made up of individuals and organisational representatives, with many others expressing an interest and wishing to be kept informed about the activities of Gloucestershire Older Persons' Assembly (GOPA).
- This is a positive start and bodes well for of developing a structure and taking the organisation forward across Gloucestershire.

Speakers Input

Pamela Tawse, Deputy Chair

Pamela welcomed everyone to this Inaugural meeting and explained the evolution of Gloucestershire Older Persons' Assembly, how Age Concern Gloucestershire had received a grant from Comic Relief and had established the Steering Committee and appointed a Facilitator. Explaining the Role of GOPA and how this 'voice' was highlighting inequalities and providing information. She acknowledged and paid tribute to the many organisations proving support and services to older people across the county.

Welcome

Dr. Ian Donald, Consultant Elderly Care, Glos. Royal Hospital

Ian began by introducing everyone to the National Service Framework (NSF) with particular reference to it being patient centred and, aiming to root out age discrimination. As 70% of hospital in-patients were over 65 the aim of the Health Service to 'get it right for older people'.

Growing Older

Things are improving with quicker access to GP's, reduced waiting times for clinics and operations, more hip replacements and cataract operations, and with waiting time in Accident & Emergency getting shorter.

Five priority areas are being addressed; Emergency Care, Intermediate care - rehabilitation, the integration of mental health care into the whole system, Long-term care (access, choice and quality of care) and Healthy Ageing. It is important to note that the listening process is two way; responding to your concerns and priorities, but also professionals need to get the message across, to educate and promote healthy ageing.

GOPA Input & Influences

Many presentations to Social Services; the Primary Health Care Trusts and the Social Services Inspectorate have been made by older people, i.e. GOPA representatives. Our interaction and networking with so many groups and

organisations has greatly helped to raise the profile and awareness of older people.

Information from the data base is providing essential detail for reports, and when supporting individuals. An example of our work was the Facilitator's attendance at the House of Commons Health Seminar, following the publication of Ombudsman's Report (February 2003) regarding unfair Nursing Care Charges. GOPA has been supporting a local family involved in these issues.

Promoting Action

Sue gave an overview of "the Debate of the Age", 1999 explaining how this had led to an Agenda for Action, with positive change occurring with the Winter Warmth allowances being paid automatically, Action on Poverty and action to curb age discrimination, and progress with health care issues developing.

Since "the Debate of the Age" the need for a collective voice has been realised with the inception of GOPA. We are all here today, to offer the opportunity to older people to actively engage in the formulation of services, through this Assembly. Sue embraced the need to involve this age group, extolling the skills and experience that are being under utilised. She pointed out that that it was up to older people to become involved via local community district meetings so passing their respective concerns to a county assembly. In this way concerns would be brought to regional meetings and solutions presented by pensioners. At present, older people are only seen as a problem, and not as a problem solvers.

The National Picture

Martin's presentation was both thought provoking and provocative, posing questions that needed close attention from the audience, which were aimed right at the heart of "What did Gloucestershire older people want from their Assembly?" This initial consideration was finely tuned to tease out from the audience their views, attitudes, ideas and needs towards an Assembly, and the direction that this organisation should take.

What is in a name?

Why do we need GOPA?

To whom is GOPA accountable?

What is the purpose of GOPA?

Who/where does GOPA seek to influence

These broad questions were eventually put as four specific questions to the group, the responses to which are shown on the next page.

As the former Programme Director of Better Government for Older People Martin was able to share with us his

experience, giving examples of organisations across the UK, their development beyond the initial stages, and the

issues that they are addressing. Imposing a specific scenario upon Gloucestershire was not the answer,

Questions raised from the floor

Health Care Issues

Pursuing only health and care issue could lead to older people being seen only as the source of a problem, and not as a resource for solving a problem.

Pension and Council Tax

These two points have generated very strong feelings and resentment. This response is as a result of the low increases in Pensions and the higher increases in Council Tax. This point has

received attention from the government and county councillors, with both blaming each other for the substantial increase.

How will GOPA "get to other older people"?

A question raised at the conference and one that is continually being asked in most parts of the county, but still a very valid one that needs addressing.

Increasing the membership of GOPA

This perhaps is within the next phase of the Assembly and one in which Martin Shreeve can guide us.

Why do we need Gloucestershire Older Persons' Assembly?

- To bring together, across generations, service providers, older peoples groups, to visit N/R homes and generally help older people 1
- For a Cross Cutting body, developing the NSF, illustrating healthy lifestyle and to act as resource and solution 1
- Because being in contact means we are not alone 1
- To act as an advocate 1
- To help group the various bodies to make a stronger voice 2
- To educate older & younger people and other interested parties 2
- To providing an information network and direct people to services 4
- For researching, to be "own voice" and represent older people 11

Martin Shreeve's evaluation of the views from those attending the Initial Assembly, expressed in the "post it", (which is fully analysed below) are these:-

1. An Assembly that was accountable to all older people in Gloucestershire.
2. An Assembly that had a co-ordinating function as an information resource for older people in the County.
3. An Assembly that sought to influence local services.
4. An Assembly that sought to influence Central Government policy.
5. The Assembly membership should be of older people rather than of organisations representing older

Written comments handed in at the end

- Many Churches hold older people's groups, this is a potential access to older people.
- The forthcoming changes to Post Office collection of Pensions, the use of a pin number and a plastic card, are of considerable concern to a large number of people.
- Bus passes continue to confuse and annoy people endeavouring to achieve a countywide approach.
- Would it not be better to invite a larger number of older people to the Assembly to speak for themselves? Listen to what older people worry about, financial security, personal security, transport and health.
- Please could you pay special attention to groups who are not normally represented by those who have no transport and on income support?
- Who is recognised by GOPA as an older person? There is no clear line as in the Victorian age! Some old at 50, others young at 90 What consultation/involvement of 'older people' has taken place in the evolution of GOPA? What do people expect of GOPA?
- National issues to be followed up: - Mental Incapacity Bill – and rights of family/nominated representatives. – Safety of Medicines, full information including adverse effects for patient and informal carers. Issue of Patient Information leaflets to carers
- Those wanting help should be encouraged to state exactly what their needs are.
